

Minutes of Annual General Meeting (AGM) of Jorhat Engineering College Alumni Association - Guwahati Chapter (JECAA-GC) held on 10th May 2026 at Hotel Gateway Grandeur, Guwahati

The AGM of JECAA-GC was held on 10th May 2026 at Hotel Gateway Grandeur, Guwahati. Er Pradip Ranjan Goswami, the President of JECAA-GC presided over the meeting. In his inaugural address, the President expressedly offered thanks and gratitude to all Alumni/Members of Guwahati Chapter for their continued support and cooperation spanning over 4(four) years. He called upon all Alumni/Members to continue supporting in the same manner in the coming days also.

- ❖ The meeting started with a devotional song by Er. Gitanjali Kakoti, an Alumnus of Guwahati Chapter.
- ❖ This was followed by Lighting of lamps as well as offering of Floral Tribute to our beloved Alumni, who left us for heavenly abode during the year 2025-26. Our respected member, Er. Thagit Nahar Deka, the senior most Alumnus of our Chapter led the members present in the meeting for this event. One-minute silence was observed as a mark of respect to the departed souls of our Alumni.
- ❖ Thereafter, the traditional Theme Song of JEC was played and all the members rose to join the song.
- ❖ The President formally declared open the AGM and the objective of the meeting was shared by the Secretary, Er. Deben Sarma.
- ❖ The Secretary read out the Annual Report on the activities taken up by the Guwahati Chapter during the year 2025-26. The report was deliberated upon by the members. Er. Paban Phukan pointed out that the Secretary's Report does have any mention regarding Prof. Sashi Sarma Memorial Talk held recently at JEC. It was decided that a Corrigendum will be issued suitably in this regard and circulated in the WhatsApp Group of Guwahati Chapter. After detailed deliberation, the meeting accepted the Secretary's Report
- ❖ The Report (Balance Sheet, Receipts & Expenditures) of the Treasurer for the year ending March 2026 was read out by Er. Nabin Ch. Sarma, the Treasurer of Guwahati Chapter. During deliberation, some of the members stated that the Treasurer's Report is not substantiated with the Auditor's Report and requested that this should be included in the Report. It is decided that this will be followed as a future guidance. Er. Sanjib Kr. Baishya pointed out that the Receipts/Expenditures related to programmes arranged exclusively through the Member's contributions may not be recorded in the Accounts. The Treasurer stated that in the event of eventual deficit (of the event), which occurred in many cases earlier, the resulting excess expenditure had to be taken care of from the Chapter's Accounts. After detailed deliberation, the meeting opined that this practice should be done away with in future and the Treasure's Report was unanimously accepted by the General Body meeting.



The meeting acknowledged the efforts of the Treasurer, Nabin Chandra Sarma for raising the position of the Fund of our Chapter to a considerable extent/comfortable level through constant appeal/personal request and all members applauded him.

- ❖ Er. Amarjit Sarma, a new Alumnus of our Chapter, who was instrumental in creating the much needed Digital Portal for online '**Registration and Payment Gateway**' including the '**Blood Donors Platform**, spoke on the relevance/use of the Portals for getting registered as Members/contributing digitally the Annual Subscription etc. He also dwelt on the use of the Portal while explaining the process involved to help the needy through the Blood Donors Portal. **The meeting acknowledged the efforts of Er. Amarjit Sarma and applauded his effort to bring our Chapter's stance to the next level.**
- ❖ Thereafter, the cultural programmes took off in which our own Alumni/family members participated. Mrs. Aparna Bhuyan Bora, Er. Gitanjali Kakoti and Er. Elora Kalita enthralled the audience with their sweet melodious songs while Er. Bhaven Goswami and Er. Prahlad S. Bhagawati entertained the audience through recitals of their own poems thanks to Er. Gautam Bora and Er. Pradip Kumar Kakoti for managing the entire cultural programme seamlessly.
- ❖ The President formally declared resignation of the existing Executive Committee of Guwahati Chapter as per the terms of the Constitution of JECAA. This was followed by selection/formation of the new Executive Committee. The List of the new Executive Committee is appended in Annexure - II.
